2. Remaining balance is before day of the wedding. **No video** will be taken until payment is received.
3. Video will be ready approximately 8-10 weeks after wedding date. (May vary depending on amount of editing required & peak wedding season.)
4. If DSD Productions is unable to perform to the guidelines of this contract due to a fire, or other casualty, strike, act of terrorism, or other cause beyond the control of the parties, or if due to a DSD Productions illness and if DSD Productions is unable to provide a Videographer that is agreeable to the client, then all fees paid by the client will be returned in full, but DSD Productions shall have no further liability with respect to the agreement. If DSD Productions is unable to perform to the obligations in this contract for any other reason, DSD Productions will not be liable for costs in excess of the amount the client has paid. This limitation of liability will also apply in the event that images are lost through camera malfunction or otherwise damaged without fault of the Videographer.
5. All rights to images created by DSD Productions will remain with DSD Productions. DSD Productions reserves the right to display footage made in conjunction with this wedding as samples of their work for the purposes of window and showroom exhibit, advertising, promotion on the internet, publication, instruction and professional competition. A video will remain a Copyright of DSD Productions.
6. Our DVDs are playable on most standard DVD players, computer DVD-ROM drives. Your DVD player should play DVD-R to be fully compatible. Please ask for more information.
